SUBCONTRACTOR AGREEMENT

I. AGREEMENT

Subcontractor, _______, hereinafter called "Subcontractor," agrees to perform labor and materials for Contractor, MW Restoration, LLC, hereinafter called "Contractor," who in turn agrees to pay Subcontractor in accordance with the terms and conditions set forth as **Exhibit A**, for satisfactory performance of the scope of work provided therein. The parties hereto agree that proper consideration arises by virtue of Subcontractor's satisfactory performance of services under this agreement, and Contractor's agreement to pay Subcontractor for services performed hereunder.

II. SCOPE OF WORK

Subcontractor shall be employed as an independent contractor and shall provide and furnish all labor, materials, supplies, equipment, services and administration necessary for the proper and complete performance of all work provided for under Exhibit A in a good and workmanlike manner, in accordance with this Subcontract Agreement, and further in accordance with the plans and specifications agreed to between Owner and Contractor:

III. COMMUNICATION

All communications between Subcontractor and Owner shall be via Contractor. Subcontractor shall furnish Contractor with periodic progress reports as required by Contractor, including status of material, equipment, manpower and submittal.

IV. NOTICE

Subcontractor shall be deemed to have received notice of a fact, request, order, or demand when its agent is notified, either orally or in writing, or three (3) days after written notice is sent by registered or certified mail addressed to Subcontractor's address, as set forth below, whichever is sooner. Contractor shall be deemed to have received notice of a fact, request, or demand three (3) days after written notice is sent by registered or certified mail addressed to the following address: MW Restoration, LLC, 2230 Bohm Drive, Little Chute, Wisconsin, 54140.

V. <u>TIME</u>

Contractor is solely responsible for scheduling and sequencing work and trades on the Project. Subcontractor shall not commence, in any way, including delivery of materials, any work prior to receipt of written notice from Contractor. Subcontractor shall commence and substantially complete all services in accordance with the start and completion dates set forth in Exhibit A.

VI. <u>INDEPENDENT CONTRACTOR STATUS</u>

Contractor and Subcontractor specifically agree and intend that an independent contractor relationship will be created under this Agreement. Contractor is interested solely in the results to be achieved while the conduct and control of the work subcontracted for under this Agreement will lie solely with the Subcontractor. Subcontractor is not to be considered as an agent or employee of Contractor for any purpose, and the employees of Subcontractor are not entitled to any of the benefits that Contractor provides to its employees.

VII. <u>INDEMNIFICATION/ HOLD HARMLESS</u>

Subcontractor shall indemnify, hold harmless and defend Contractor from and against any and all costs, expenses (including reasonable attorney's fees), liabilities, losses, damages, suits, actions, fines, penalties, claims or demands of any kind and asserted by or on behalf of any person, entity, or government authority, arising out of or in any way associated with Subcontractor's work under this Agreement, including, but not limited to, failure of Subcontractor to perform any of the services, terms, covenants, or conditions required to be performed by Subcontractor under this Agreement; any failure by Subcontractor to comply with any statutes, ordinances, regulations, laws, or orders of any governmental authority, local, State or Federal; any claims for discrimination of any nature made against Subcontractor by any third parties; and any accident, death or personal injury, or damage to or loss or theft of property, which shall occur while Subcontractor is performing under this Agreement.

VIII. INSURANCE REQUIREMENTS

At all periods of time during which Subcontractor is providing services to Contractor, Subcontractor shall have, and provide to Contractor, at Contractor's request, proof of insurance, in full force and effect, in the following respective sums:

- 1. \$1,000,000.00 General Liability Coverage.
- 2. \$1,000,000.00 Auto/Vehicle Liability Coverage.
- 3. \$100,000.00/\$500,000.00/\$100,000.00 Worker's Compensation Limits.

In addition, Subcontractor agrees to name Contractor as an additional insured on all of Subcontractor's liability insurance policies. Subcontractor further agrees to granting of a waiver of any and all of its potential and/or actual subrogation interests on all of Contractor's liability insurance policies.

IX. TERMINATION OF SERVICES / LIEN WAIVER

Contractor, in its sole discretion, may terminate the services under this Agreement for any reason whatsoever, and shall only be responsible for payment to Subcontractor for services actually performed and/or goods and materials provided to the date of termination. Subcontractor hereby agrees to sign a lien waiver prior to receiving final payment for completion of the services Subcontractor has performed under this Agreement, regardless of how termination of Subcontractor's services occurs.

XII. GOVERNING LAW AND RULES OF CONSTRUCTION

The validity, interpretation and performance of this Subcontract shall be governed by the laws of the State of Wisconsin, with Outagamie County as place of venue for any action arising under this Agreement. Titles, captions, or headings to any provision, article, etc., shall not limit the full contents of the same. These articles have the full force and effect as if no titles existed. If any term or provision of this Subcontract is determined to be invalid, it shall not affect the validity and enforcement of the remaining terms and provisions of this Subcontract. This contract shall be binding upon and inure to the benefit of the respective successors, assigns, representatives, and heirs of the parties herein

XIII. AMENDMENT

This Subcontract shall only be amended or modified by written document duly executed by authorized representatives of Contractor and Subcontractor.

XIV. ENTIRE AGREEMENT

This Subcontract supersedes all prior representations made by Contractor and constitutes the entire agreement by and between Contractor and Subcontractor regarding the Scope of Work defined above.

Independent Contractor Definition Under s. 102.07(8), Wis. Stats.

Under section 102.07(8)¹ of the Wisconsin Statutes, a person is required to meet a nine-part test before he or she is considered an independent contractor rather than an employee. A person is not an independent contractor for worker's compensation purposes just because the person says they are, or because the contractor over them says so, or because they both say so, or even if other regulators (including the federal government and other state agencies) say so. The nine-part statutory test set forth under s. 102.07(8) of the Act, must be met before a person working under another person is considered not to be an employee. To be considered an independent contractor and not an employee, an individual <u>must meet and maintain all nine of the following requirements:</u>

- 1. Maintain a separate business.
- Obtain a Federal Employer Identification number from the Federal Internal Revenue Service (IRS)
 <u>or</u> have filed business or self-employment income tax returns with the IRS based on the work or service in the previous year. (See note below.)
- 3. Operate under specific contracts.
- 4. Be responsible for operating expenses under the contracts.
- 5. Be responsible for satisfactory performance of the work under the contracts.
- 6. Be paid per contract, per job, by commission or by competitive bid.
- 7. Be subject to profit or loss in performing the work under the contracts.
- 8. Have recurring business liabilities and obligations.
- 9. Be in a position to succeed or fail if business expense exceeds income.

Note: When requesting a Federal Employer Identification Number (FEIN) from the IRS, you must inform the IRS that you are *required by Wisconsin Worker's Compensation law* to obtain a FEIN. A social security number cannot be substituted for a FEIN and does not meet the legal burden of s. 102.07(8).

⁽b) An independent contractor is not an employee of an employer for whom the independent contractor performs work or services if the independent contractor meets all of the following conditions:

^{1.} Maintains a separate business with his or her own office, equipment, materials and other facilities.

Holds or has applied for a federal employer identification number with the federal internal revenue service or has filed business or self-employment income tax returns with the federal internal revenue service based on that work or service in the previous year.

Operates under contracts to perform specific services or work for specific amounts of money and under which the independent contractor controls the means of performing the services or work.

^{4.} Incurs the main expenses related to the service or work that he or she performs under contract.

Is responsible for the satisfactory completion of work or services that he or she contracts to perform and is liable for a failure to complete the work or service.

Receives compensation for work or service performed under a contract on a commission or per job or competitive bid basis and not on any other basis.

^{7.} May realize a profit or suffer a loss under contracts to perform work or service.

Special rules for partnerships. Partnerships that conduct a trade or business in the United States are generally required to pay a withholding tax under section 1446 on any foreign partners' share of effectively connected taxable income from such business. Further, in certain cases where a Form W-9 has not been received, the rules under section 1446 require a partnership to presume that a partner is a foreign person, and pay the section 1446 withholding tax. Therefore, if you are a U.S. person that is a partner in a partnership conducting a trade or business in the United States, provide Form W-9 to the partnership to establish your U.S. status and avoid section 1446 withholding on your share of partnership income.

In the cases below, the following person must give Form W-9 to the partnership for purposes of establishing its U.S. status and avoiding withholding on its allocable share of net income from the partnership conducting a trade or business in the United States.

- In the case of a disregarded entity with a U.S. owner, the U.S. owner of the disregarded entity and not the entity;
- In the case of a grantor trust with a U.S. grantor or other U.S. owner, generally, the U.S. grantor or other U.S. owner of the grantor trust and not the trust; and
- In the case of a U.S. trust (other than a grantor trust), the U.S. trust (other than a grantor trust) and not the beneficiaries of the trust.

Foreign person. If you are a foreign person or the U.S. branch of a foreign bank that has elected to be treated as a U.S. person, do not use Form W-9. Instead, use the appropriate Form W-8 or Form 8233 (see Pub. 515, Withholding of Tax on Nonresident Aliens and Foreign Entities).

Nonresident alien who becomes a resident alien. Generally, only a nonresident alien individual may use the terms of a tax treaty to reduce or eliminate U.S. tax on certain types of income. However, most tax treaties contain a provision known as a "saving clause." Exceptions specified in the saving clause may permit an exemption from tax to continue for certain types of income even after the payee has otherwise become a U.S. resident alien for tax purposes.

If you are a U.S. resident alien who is relying on an exception contained in the saving clause of a tax treaty to claim an exemption from U.S. tax on certain types of income, you must attach a statement to Form W-9 that specifies the following five items.

- The treaty country. Generally, this must be the same treaty under which you claimed exemption from tax as a nonresident alien.
 - 2. The treaty article addressing the income.
- 4. The type and amount of income that qualifies for the exemption from tax.
- Sufficient facts to justify the exemption from tax under the terms of the treaty article.

Example. Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if his or her stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first protocol) and is relying on this exception to claim an exemption from tax on his or her scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident alien or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

Backup Withholding

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS 28% of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

Payments you receive will be subject to backup withholding if:

- 1. You do not furnish your TIN to the requester,
- 2. You do not certify your TIN when required (see the instructions for Part II for details),
 - 3. The IRS tells the requester that you furnished an incorrect TIN,
- 4. The IRS tells you that you are subject to backup withholding because you did not report all your interest and dividends on your tax return (for reportable interest and dividends only), or
- 5. You do not certify to the requester that you are not subject to backup withholding under 4 above (for reportable interest and dividend accounts opened after 1983 only).

Certain payees and payments are exempt from backup withholding. See Exempt payee code, later, and the separate Instructions for the Requester of Form W-9 for more information.

What is FATCA Reporting?

The Foreign Account Tax Compliance Act (FATCA) requires a participating foreign financial institution to report all United States account holders that are specified United States persons. Certain payees are exempt from FATCA reporting. See Exemption from FATCA reporting code, later, and the Instructions for the Requester of Form W-9 for more information.

Updating Your Information

You must provide updated information to any person to whom you claimed to be an exempt payee if you are no longer an exempt payee and anticipate receiving reportable payments in the future from this person. For example, you may need to provide updated information if you are a C corporation that elects to be an S corporation, or if you no longer are tax exempt. In addition, you must furnish a new Form W-9 if the name or TIN changes for the account; for example, if the grantor of a grantor trust dies.

Penalties

Failure to furnish TIN. If you fail to furnish your correct TIN to a requester, you are subject to a penalty of \$50 for each such failure unless your failure is due to reasonable cause and not to willful neglect.

Civil penalty for false information with respect to withholding. If you make a false statement with no reasonable basis that results in no backup withholding, you are subject to a \$500 penalty.

Criminal penalty for falsifying information. Willfully falsifying certifications or affirmations may subject you to criminal penalties including fines and/or imprisonment.

Misuse of TINs. If the requester discloses or uses TINs in violation of federal law, the requester may be subject to civil and criminal penalties.

The name on line 1 should be the name shown on the income tax return on which the income should be reported. For example, if a foreign LLC that is treated as a disregarded entity for U.S. federal tax purposes has a single owner that is a U.S. person, the U.S. owner's name is required to be provided on line 1. Line 5

If this address differs from the one the requester already has on file, write NEW at the top. Line 6

Enter your city, state, and ZIP code.

Part I. Taxpayer Identification Number (TIN)

Enter your TIN in the appropriate box. If you are a resident alien and you do not have and are not eligible to get an SSN, your TIN is your IRS individual taxpayer identification number (ITIN). Enter it in the social security number box. If you do not have an ITIN, see *How to get a TIN* below.

If you are a sole proprietor and you have an EIN, you may enter either your SSN or EIN.

If you are asked to complete Form W-9 but do not have a TIN, apply for a TIN and write "Applied For" in the space for the TIN, sign and date the form, and give it to the requester. For interest and dividend payments, and certain payments made with respect to readily tradable instruments, generally you will have 60 days to get a TIN and give it to the requester before you are subject to backup withholding on payments. The 60-day rule does not apply to other types of payments. You will be subject to backup withholding on all such payments until you provide your TIN to the requester.

Note: Entering "Applied For" means that you have already applied for a TIN or that you intend to apply for one soon.

Secure Your Tax Records From Identity Theft

Identity theft occurs when someone uses your personal information such as your name, SSN, or other identifying information, without your permission, to commit fraud or other crimes. An identity thief may use your SSN to get a job or may file a tax return using your SSN to receive a refund.

To reduce your risk:

- · Protect your SSN,
- Ensure your employer is protecting your SSN, and
- Be careful when choosing a tax preparer.

If your tax records are affected by identity theft and you receive a notice from the IRS, respond right away to the name and phone number printed on the IRS notice or letter.

If your tax records are not currently affected by identity theft but you think you are at risk due to a lost or stolen purse or wallet, questionable credit card activity or credit report, contact the IRS Identity Theft Hotline at 1-800-908-4490 or submit Form 14039.

Victims of identity theft who are experiencing economic harm or a systemic problem, or are seeking help in resolving tax problems that have not been resolved through normal channels, may be eligible for Taxpayer Advocate Service (TAS) assistance. Protect yourself from suspicious emails or phishing schemes. Phishing is the creation and use of email and websites designed to mimic legitimate business emails and websites. The most common act is sending an email to a user falsely claiming to be an established legitimate enterprise in an attempt to scam the user into surrendering private information that will be used for identity theft.

The IRS does not initiate contacts with taxpayers via emails. Also, the IRS does not request personal detailed information through email or ask taxpayers for the PIN numbers, passwords, or similar secret access information for their credit card, bank, or other financial accounts.

If you receive an unsolicited email claiming to be from the IRS, forward this message to *phishing@irs.gov*. You may also report misuse of the IRS name, logo, or other IRS property to the Treasury Inspector General for Tax Administration (TIGTA) at 1-800-366-4484. You can forward suspicious emails to the Federal Trade Commission at *spam@uce.gov* or report them at *www.ftc.gov/complaint*. You can contact the FTC at *www.ftc.gov/idtheft* or 877-IDTHEFT (877-438-4338). If you have been the victim of identity theft, see *www.IdentityTheft.gov* and Pub. 5037.

Privacy Act Notice

Section 6109 of the Internal Revenue Code requires you to provide your correct TIN to persons (including federal agencies) who are required to file information returns with the IRS to report interest, dividends, or certain other income paid to you; mortgage interest you paid; the acquisition or abandonment of secured property; the cancellation of debt; or contributions you made to an IRA, Archer MSA, or HSA.
